

Designed for you, by you

3. The Investment Governance Service confirms which funds/portfolios from the available suite are appropriate for the identified risk score, using market leading analysis of performance data by ARC.



4. You decide which of the identified funds/portfolios to invest in and then action this through the platform with just a few clicks of the mouse.
5. Ongoing governance provided by way of quarterly reports confirming if chosen investments remain appropriate for the risk mandate, comparison of performance relative to other portfolios meeting the established risk profile and a traffic light system to flag performance and management issues.
